URGENT – Government Request for Hospital Lab Data on COVID-19 Testing

The federal government has requested that AHA collect daily data reports on COVID-19 testing in hospital-based labs. If your hospital is not currently running COVID-19 tests in its own lab, you do not need to respond.

This survey will respond to the immediate needs of the federal government and is an update to prior requests. The Administration is seeking this information in order to monitor the trajectory of positive test results and coordinate its COVID-19 response. The data is being collected from all state and public health laboratories, along with LabCorp, BioReference Laboratories, Sonic Healthcare USA, Quest Diagnostics, Mayo Clinic Laboratories, and ARUP Laboratories.

We are requesting that any hospital laboratory that is currently performing testing for SARS CoV-2 provide AHA with data using the link and log-in information below. Please provide this data daily by 5 pm ET for all test results completed during the previous day (cutoff time 12 midnight-previous day).

Again, any member that is sending their COVID-19 tests out to any of the above mentioned laboratories does not need to send this data. You only need to send data if there is in house testing being performed for COVID-19 that is not being sent to one of the laboratories named above.

Please forward the survey link to the appropriate contact within your organization and urge them to submit your results daily.
